Gerry Kostyk presents the proposed adjustment;

The adjustment involves parcels 72.74-1-31.1 (Rawson residential lot, 130 Brainard Ave), 72.74-1-31.3 (Lisa Chapin), and 72.74-1-31.4 (Rawson). The Rawson's are keeping 31.1, residential lot. Lisa Chapin is keeping lot 31.3 (conveying a small portion to the north to Rawson). Lisa and Jeff Chapin are purchasing 31.4 (conveying a small portion to the north to Rawson). These two small portions will be added to the Rawson's residential lot 31.1. The two Chapin lots will remain as separate lots 31.3 and 31.4.

Alexander Hood, representative of Intelligent Green Solution explains proposed project:

- -32 panel, 12.96 KW solar array, standard system
- -facing the west/southwest, backside of roof, rear yard, out of sight
- -residential, will offset the regular electrical usage
- -tied into existing grid, excess production flows back on to the grid giving 1:1 credit to the user
- -Eliminates electric bill for National Grid

Board: Will there be lithium batteries involved?

Hood: -no lithium batteries involved

- -low chance of battery request for this type of system, if request is made would need to go through permitting process again
- -interconnection agreement

Board: Who disposes of the solar panels if new buyer doesn't want system etc.?

Hood: -systems are normally an asset and kept by new buyers

-life of system- warranty for 25 years, will slowly loose efficiency therefore systems are purposely oversized when installed. Built to last 30-40 years. Made with recyclable materials, can be upcycled into smaller items that use solar, for example garden lighting. Green Solutions will take panels back even at end of life.
