Mayor Eves open-up the floor to Mr. Eugene McIntosh at 4:02 p.m.

Since June 21st board meeting Mr. McIntosh had areas of concern to clear up, starting with pictures shown to Trustee Stano with date stamp of registered trailer he used for hauling to show it was current. At the last meeting it was questioned if it was a junk trailer. Second picture of wooden spools with the date also shown. Mr. McIntosh also clarified if Mat Shawcross had requested in the past, to move his vehicle off the road for plowing purposes. Mat did not recall doing that.

Mr. McIntosh got a tax identification number and filed for a license to do business as, for small engine sales selling lawn mowers on Facebook Marketplace and picking up at his residence. He does no lawn mower repairs at his residence. These were items discussed at the previous meeting recommending to be done if he was going to conduct a business.

The summons letter, for property maintenance violations, to report to Town of Brownville Court on July 28th 2022 was also discussed. Trustee Stano asked why he received a letter to appear due to an extension being given at previous meeting by the board. Jim Millington, Code Enforcer said he would contact court to give a stay until after September 30th, if still needed. Mr. Millington would ensure it was in writing prior to court date.

Mr. McIntosh acknowledge that in the past he and Jim Millington measured the 33ft. from center of the road to yard and all belongings had to be beyond that point. He recalled and understood the right of way had to be clear.

Mr. McIntosh wanted to know what the code was for cameras, then explained of two cameras, one across the street facing front of his house and one on the corner of the neighbor’s house with voice, pointed at the back of his yard. He was told that it is a civil matter and he would have to contact police.

Mr. McIntosh then asked what the law was for discharging a firearm in the village. He has a pistol permit license to conceal and carry for a magnum 357. He was tired of people coming into his yard and wanted to know when it was self-defense and at what point he could discharge his gun and the repercussions if he did?

Again, he was told it was a civil matter and to contact sheriff's office if he had questions or concerns. He claimed they would never come if called.

Danielle discussed the paperwork sent to him for special use permit and what was still needed for it to be presented to planning board to include a site plan. He said he had his daughter fill out paperwork, he did not understand what he had to do. She discussed he would need to get a special use permit for a business in a residential neighborhood, and Trustee Renee Stano tried to explain the special use permit to him. He said he had gotten a permit in the past year for the building he wanted to put in the yard for a woodworking shop. Jim Millington reiterated a home occupation all items have to be contained in a structure. Mr. McIntosh said he would add a lean to on the back of the building for lawn mowers with sides and opening against the fence. Danielle would look into the previous permit and the expiration. He asked Danielle if he could call her if he had any further questions in regards to the special use permit.
