**INSPECTION REPORTS**

Mayor James Eves - Sewer Treatment Plant – Progression of UV Disinfection Project  
EFC has awarded the Village \$1,800,000 for the UV Disinfection project in addition to the \$245,513. For the Water Infrastructure Improvement Act (WIIA) grant.  
\$1,000,000 Water Quality Improvement Project (WQIP) grant.  
Also considered was the loan available to the village for the costs not covered by the grants:  
\$883,000 CWSRF interest-free 30-year loan
